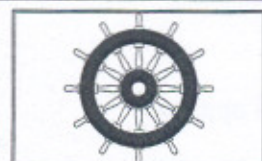

The non-combustible material used on board of sea-going vessels shall comply in every respect with the non-combustible material which has been tested.

The non-combustible material shall be marked in accordance with Article 11 of the Council Directive 96/98/EC of 20 December 1996 on Marine Equipment as amended.
